ORDINANCE NO. 951

AN ORDINANCE CREATING THE CULTURE AND ARTS COUNCIL
OF THE CITY OF CANDON, PROVINCE OF ILOCOS SUR

BE IT ORDAINED by the Sangguniang Panlungsod of the City of Candon,
Province of Ilocos Sur in regular session assembled;

Section 1. Short Title. This Ordinance shall be known as "Culture and Arts
Council Ordinance of the City of Candon".

Section 2. Aim and Purpose. This Ordinance has the following purpose:

1. To maintain a Culture of, by and for the Candonian People which is independent, equitable, progressive, humanistic, pluralistic, democratic, nonpartisan, liberative and nationalistic;
2. To protect, preserve and promote the Candonian identity and cultural property;
3. To support and develop Candonian artists, cultural workers and cultural institutions;
4. To encourage and disseminate the creation of artistic and cultural products to the greatest number of Candonians; and
5. To uphold freedom of belief and of expression, which is a human right that should be accorded due respect and allowed to flourish.

Section 3. Composition of the Local Culture and Arts Council. The council shall be composed of the following:

Chair: City Mayor
Vice Chair: City Vice Mayor
Members: House Representative of the 2nd District of Ilocos Sur or his/her duly authorized representative
Chairperson, Vice Chairperson and Members of the SP Committee on Culture and the Arts and Historical Research
The Indigenous Peoples Mandatory Representative to the SP
The Association of Barangay Captains President
The City Planning and Development Officer
The City Information Officer
The City Budget Officer
The City Tourism Officer
Representative, MDS Heritage Music Foundation Inc.
Representative, Council for Culture, Arts and Tourism (CCAT).
Representative, Department of Education (DepEd Division)
Representative, Technical Education and Skills Development Authority (TESDA)
Representative, Local Tourism Council
Representative, Local Historical/Heritage Society or any sectarian organization, if any Representative, Local Museums
Representative, Local Artists Groups
