## **ORDINANCE NO. 980**

AN ORDINANCE GRANTING TEN PERCENT (10%) DISCOUNT ON STALL RENTAL FEES IN CERTAIN CITY ECONOMIC ENTERPRISE BUILDINGS DURING ENHANCED COMMUNITY QUARANTINE (ECQ) OR MODIFIED ENHANCED COMMUNITY QUARANTINE (MECQ) CLASSIFICATION IN THE CITY OF CANDON, PROVINCE OF ILOCOS SUR

**BE IT ENACTED** by the Sangguniang Panlungsod of the City of Candon, Province of Ilocos Sur in session duly assembled, that:

## **SECTION 1. Granting of Discount.**

- a) There is hereby granted a ten percent (10%) discount on stall rental fees at the Candon City Commercial Complex, Candon Shopping Mall, Candon Arcade and Candon Trade Center during Enhanced Community Quarantine (ECQ) or Modified Enhanced Community Quarantine (MECQ) classification in the City of Candon.
- b) There is hereby granted a ten percent (10%) discount on stall rental fees at the Candon City Farmers Market only during Enhanced Community Quarantine (ECQ) classification in the City of Candon.
- c) Rentals for stalls that are not permitted to open by the government during ECQ or MECQ classification are hereby condoned during the duration of their closure.

**SECTION 2.** Repealing Clause. All existing ordinances or parts thereof inconsistent, or in conflict with this Ordinance are hereby repealed or modified accordingly.

**SECTION 3.** <u>Effectivity.</u> This Ordinance shall take effect immediately upon approval.
